NOTICE TO POLICYHOLDERS

Regarding the Liquidation of Weston Property and Casualty Insurance Company

Dear Policyholder:

This letter is being sent to you because our records indicate that you are a policyholder of Weston Property and Casualty Insurance Company ("Weston"). On August 8, 2022, Weston was placed in receivership and ordered into liquidation by the Second Judicial Circuit Court of Leon County, Florida (the "Court") in Case Number 2022-CA-001378. **Unless it was canceled earlier, your coverage will be canceled effective 12:01 a.m. on September 7, 2022.** The Florida Department of Financial Services was appointed by the Court as Receiver of Weston, and CANTILO & BENNETT, L.L.P. was appointed by the Receiver as the Special Deputy Receiver ("SDR") of Weston. The SDR, under the Receiver's supervision, is responsible for administration of Weston and its property. A copy of the liquidation order for Weston and other relevant information is available at the SDR's web site at www.weston-ins-liquidation.com.

If you have not already discussed this matter with your agent, please contact your agent immediately to make sure that you get new coverage to replace your Weston policy. Your agent is in the best position to advise you as to your insurance options. To assist your agent, and you in this process, we have notified your agent that your policy will be canceled.

POLICY CANCELLATION: Continued, uninterrupted property coverage is particularly important during hurricane season. Under the liquidation order, your Weston policy will be canceled effective 12:01 a.m. on September 7, 2022, unless otherwise terminated prior to that date.

CONTACT YOUR AGENT IMMEDIATELY so that your agent can assist you in securing new insurance coverage with another insurance company prior to **September 7, 2022**. **IF YOU DO NOTHING, YOUR POLICY WILL BE CANCELED EFFECTIVE 12:01 A.M. ON SEPTEMBER 7, 2022, AND YOU WILL NO LONGER HAVE INSURANCE COVERAGE.**

CLAIMS FOR LOSSES INCURRED PRIOR TO 12:01 A.M. SEPTEMBER 7, 2022: Claims for losses incurred prior to September 7, 2022, will be handled by your state's insurance guaranty association. For contact information regarding your state's insurance guaranty association please visit the SDR's web site at www.weston-ins-liquidation.com.

The deadline for filing claims in the Weston receivership is August 8, 2023. Claim filing forms and information will be available on the liquidation web site at www.weston-ins-liquidation.com.

PROCESS FOR PAYMENT OF CLAIMS: The SDR is currently gathering claim files and claim data to forward to state guaranty associations. As a result, there may be a slight delay in claim processing during this transitional period. Please continue to contact Weston using the contact information below to check the status of an existing claim and/or to file a new claim. The SDR's web site, www.weston-ins-liquidation.com, will be updated once this process is completed.

RETURN PREMIUM: Return premiums may be covered by your state's guaranty association. Once all policies are canceled, the SDR will calculate the return premium amounts due to policyholders. Once completed, the information will be sent to the guaranty associations for processing and payment. This process will take approximately 30 to 60 days from September 7, 2022. This time is required to correctly calculate the return premium amounts, transmit the data to state guaranty associations and allow the guaranty associations the time necessary to process, print, and mail checks. At this time, we ask that you refrain from contacting state guaranty associations until the cancellation, calculation, and submission of the return premium data is completed.
